B. Personal Property Tax and Delinquent Tax follow up report from Town Treasurer

Lisa reported that notices have been sent out to the delinquent tax payers and she has collected some money. Unpaid personal property taxes will be added to the 2003 real estate tax bill and paid to the town before credit is given to the property tax.
