B. DNR Grant for dry hydrants update. Discussion and possible action The fire department received a grant from the DNR to install three dry hydrants in Sugar Camp Lake, Jenny Weber Lake and Lilly Bass Lake. However, another department within the DNR has denied permission to actually install the hydrants. The fire department did receive permission to use the money for other projects. This has been a very frustrating experience for the department and the former Fire Chief who has spent many hours writing grants only to win the grant but not get permission to use the grant for the purpose it was written for.
