10. Discuss disc gold course fees

11. Discuss Frontier bill for Town services

- *Clerk Sowinski informed the Board that the Frontier bill continues to increase every month. After speaking with Frontier, our bill could be decreased if we remove phone lines and commit to a contract. The Board suggested to start by removing phone lines – the Town Shop line, phone line by the bar in the Town Hall, and the fax line. The Board asked for Clerk Sowinski to get a contract price in writing from Frontier and it will be reviewed next month.*

12. Discuss potential ‘Foundation’ donation to the Town Hall

- *Clerk Sowinski informed the Board that a town resident asking about making a donation on behalf of her foundation to go directly towards renovations to the interior of the Town Hall. Discussion from the Board – that cannot be done because the donation would have to be to a non-profit, they advise the resident to donate to the Lions Club to assist with upgrades to the playground.*
