Changes in the ordinance are as follows under item 2:

- (2) Definitions:
 - (a) Subdivision. Two formulas will apply:

- 1. Two or more lots of five acres or less created by survey, plat or any other means from one original parcel within a five-year period.
- 2. Three or more lots of ten acres or less created by survey, plat or any other means from one original parcel within a five year period.
